Name of Winning Bidder, and the price it offered: PNG Constructions Ltd for PGK3,680,084.87 being the lowest evaluated substantially responsive bidder among the responsive qualified bidders.

Duration and summary scope of contract awarded: A contract was awarded to PNG Constructions Ltd for PGK3,680,084.87 (inclusive of GST) for the construction and completion of a community health post, 3 staff houses, 1 ablution block, 1 incinerator shed and 1 generator shed at Yasubi in Okapa District over 12 months starting March 2015.
